## CODE OF CONDUCT

As a financial member of Collarroy SLSC for the 2021/2022 season agree to abide by the following terms and conditions as a member of the Collarroy SLSC Touring Team for the 2021/2022 Age State Championships Blacksmiths Beach & Redhead Beach NSW. (Hereafter referred to as "the championships").

I acknowledge that the Club, Committee, employees, agents, members, voluntary workers and their successors (hereafter referred to as "the club") do not accept responsibility for damage or loss of property of any member for the travel to and from whilst attending the championships.

I indemnify and agree to hold the Club free of all loss, damages, cost or other claims whatsoever arising from any personal injury, damage or loss of property suffered or incurred by me for the travel to and from and whilst attending the championships.

### CODE OF CONDUCT

Alcohol consumption by members under the age of 18 will not be tolerated.

Any damage to property at your accommodation or gear is to be reported to the JAB Chairman, Craig Thomas immediately.

Any curfew applied by the JAB Chairman must be strictly adhered to.

No Touring Team garments are to be exchanged with persons outside Collarroy SLSC members.

The clubs Social Media Policy is to be strictly adhered to by all members.

Any persons found by the Disciplinary Committee to be contradiction of the code may be suspended from the championships and sent home at their own expense.

### RULE 12 (Taken from the club Statement of Objects & Rules - 2004 Revision)

12.1 The office bearers of the Club from time to time referred to in Rule 15.2 hereof or a majority of them may then (if they are of the opinion as referred to in Rule 12.2 hereof in respect of a member of the Club) forthwith and without notice suspend such member from membership of the Club for a period not exceeding seven days pending the operation of the following conditions of this rule.

12.2 Where the committee is of the opinion that a member of the Club;

- a) Has refused or neglected to comply with a provision or provisions of these rules; or
- b) Has wilfully acted in a manner prejudicial to the interests of the Club or SLSA, the Committee may, by resolution;
- c) Expel the member from the Club; or
- d) Suspend the member from membership of the Club for a specified period.

12.3 A resolution of the Committee under rule 12.2 is of no effect unless the Committee, at a meeting held not earlier than 14 days and not later than 28 days after service on the member of a notice under rule 12.4 confirms the resolution in accordance with this rule.
